#### PERMIT CONDITIONS

The following conditions must be adhered to when executing this permit.

- 1. The person performing the burning operation to which the permit relates must be in possession of the permit or a copy of it and present it upon request of any Authorised person.
- 2. Burning off must occur between 9am and 4pm EST.
- 3. Notify neighbours at least two hours before starting to burn.
- 4. Notify the Emergency Service Telecommunications Authority (ESTA) on 1800 668
- **5.** Check the weather forecast for the day of the burn and a few days afterwards
- 6. Establish a firebreak no less than three meters cleared of all flammable material
- 7. Ensure there is enough people to monitor, contain and extinguish the burn safely and effectively

- 8. Burning off must not be allowed to cause a smoke nuisance or endanger the health of any other person.
- 9. The fire must be completely extinguished before the permit holder leaves
- **10.** If in the vicinity of the area to burned, the shade temperature exceeds 32 degrees Celsius or the average wind speed exceed 15 kilometers per hour:
  - i. Burning operations must not commence; or
  - ii. An adequate number of adults and reticulated water (town supply) or adequate fire suppression equipment appliances must remain present until the fire is completely extinguished
- 11. No person shall burn or cause to be burned any of the following or any substance containing any of the following:
  - any household waste;
  - any manufactured chemicals; (b)
  - any rubber or plastic; (c)
  - any petroleum, oil or derivative thereof; (d)
  - any paint or receptacle which contains or which contained paint; (e)
  - food waste, fish or other offensive or noxious matter; (f)
  - any explosive material or container which may cause an explosion; (g)
  - (h) cardboard or newspaper; or:
  - any other material deemed offensive or dangerous by an Authorised Officer of (i) the Council

#### SHOULD THE PERMIT HOLDER BREACH ANY OF THE CONDITIONS STATED

- The permit will be cancelled and the fire ordered to be immediately extinguished. (a)
- The organisation or individual may have future permit applications refused. (b)
- The organisation or individual may receive fines for any or all breaches.
- Costs incurred to Council due to rectifying any breach will be levied against the permit holder.
- Severe penalties including prosecution may apply if your fire should endanger life or damage another person's property.

#### **IMPORTANT NOTICE**

This permit authorises the permit holder to operate only to the extent that Councils is able to grant this authority. It may be that the permission, approval, consent or authority of some other person or entity must be obtained. Nothing in this permit represents (or should be taken as representing) that
